Sub: Notification of latest schedule of Laboratory Test Charges,

Tatkal Scheme and Discount Scheme - regarding

(A) Revised Test Charges:

The Textiles Committee Laboratories located at various major textile centres spread across India offer testing services for various Chemical, Mechanical and Ecological test parameters to the textile trade and industry. Uniform test charges at all over India are collected as per the prescribed rates from the Customers. The test charges are revised from time to time in tune with the exigencies of time and cost requirements. The last revision of test charges for the various parameters was done during the year 2008 and the cost escalations over the last 10 years has necessitated a revision and accordingly the test charges have now been revised/rationalised with effect from 5th February, 2018 and the revised rate has been approved by the Board of the Textiles Committee in its 120th meeting held on 8th January, 2018. The different tests offered by Textiles Committee and their respective revised charges are uploaded in the website of Textiles Committee for ready reference of all the customers/stake holders (website: www.textilescommittee.gov.in).

(B) Tatkal Scheme:

2. In order to facilitate the trade and industry for their emergency requirement for speedy issuance of test results, a Tatkal Scheme has also been introduced based on which the test results are issued within the minimum stipulated time (within a day in many cases). A nominal additional charge of 50% of the scheduled test charges is levied for the same. Customer who want out of turn and expeditious services can opt for Tatkal Scheme from the following Notified Laboratories of Textiles Committee:

(i) Bangalore (ii) Cannanore (iii) Chennai (iv) Coimbatore (v) Hyderabad (vi) Jaipur (vii) Kanpur (viii) Kolkata (ix) Ludhiana (x) Mumbai (xi) JNPT, Navi Mumbai (xii) New Delhi (N) and (xiii) Tirupur

(C) Discount Scheme:

- 3. Further to incentivise loyal bulk customers, a discount scheme has also been introduced wherein the bulk customers are offered discounts as given below:
 - (i) 10% Discount on the cumulative test charges for tests done in any particular bulk customer in a Financial Year :- Above Rs.2.00 lakhs upto Rs.5.00 lakhs worth of test charges.
 - (ii) 15% Discount on the cumulative test charges for tests done in any particular bulk customer in a financial year :- Above Rs.5.00 lakhs worth of test charges.

The above Discount Scheme is applicable on the consolidated test charges (Excluding taxes) other than the test charges collected from Tatkal Testing.

- 4. The latest schedule of test charges has been revised after lapse of almost 10 years with a view to provide best possible services to our esteemed customers. Moreover, introduction of Tatkal Scheme for express and out of turn service as well as discount scheme is also intended towards facilitating services and incentivising loyal customers.
